We're excited to share that we've been selected as a recipient of Athletic Brewing Company's Two for the Trails grant! Through their Two for the Trails program, Athletic Brewing contributes up to \$2 million annually to help protect, preserve, and maintain local trails. With this grant, we're planning to finish the Middle Fork Trail reroute in Chugach State Park next summer. One week of paid trail work and two volunteer events will finally complete this project that has been ongoing for many years, and we hope you are as thrilled about it as we are!

Nov 4

Alaska Trails is grateful to be a National Forest Foundation grantee in the U.S. Forest Service - Chugach National Forest! These funds have been used to make essential

improvements to the Iditarod National Historic Trail.



This past summer, an Alaska Trails crew greatly improved sections of the Lost Lake Trail by brushing 28,178 feet (5.34 miles) of trail. They also widened and retreaded two sections of trail, cleared 30 drains, and created five more drains.

This section of trail will be more fun for mountain bikers and hikers alike since the drainage structures that were cleared and added give water someplace other than the trail surface to run to, reducing mud. Since the corridor was cleared of brush, debris, and hazard trees, trail users have better sightlines, allowing for a safer experience on the trail by avoiding potential close-up wildlife encounters or fast-moving mountain bikes.

The Lost Lake Trail is part of the Iditarod National Historic Trail (INHT). By keeping this trail open, clear, dry, and sustainable to trail users, it preserves a part of Alaskan history. When trail users walk the INHT, they're walking in the footsteps of Alaska's

indigenous people, and its gold miners, pioneers, and dogsled mushers.

DIRECTOR'S CORNER

Looking Back: Great Progress Looking Ahead: Great Plans



As we look back on a successful 2024, Alaska Trails is planning for a bright future for trails in 2025 and beyond.

Alaska Long Trail

We are making significant and steady progress on the Alaska Long Trail and many other projects for land managers across the state, and we will keep that momentum going in the new year. Alaska Trails worked together with partners to secure more funding for the Alaska Long Trail in the FY2025 state capital budget while completing work on the Eklutna Lakeside Trail and making great strides in Indian Valley and the Ram Valley access project – all three of which received funding in FY2024.

We are ready to continue the work of securing the rest of the funding to connect 500+ miles of Alaska via a sustainable and exceptional trail system. Alaska Trails will continue to work with its partners to highlight the great trails on the Long Trail route that already exist and to connect the dots to make this expansive vision a reality.

Race Across Alaska

In addition, the Race Across Alaska Winter Challenge (RAAWC) continues to raise both awareness



and funding for the Long Trail, with over \$150,000 to date. We hope you will join in on this fun event that encourages healthy recreation all winter while helping us keep the momentum going on the AK Long Trail. Staying healthy, both mentally and physically, can be challenging during this dark time of the year. Recreating on trails is a great way for Alaskans to bolster both physical and mental health.

The RAAWC is a multi-sport, multi-distance winter challenge with the goal to log as many miles as you can over 3 months. It's a great way to stay active during the winter as you can walk, run, fat tire bike, trainer bike, cross-country ski or swim. This year, two other non-profits are also beneficiaries – the Anchorage Park Foundation and the Mat-Su Trails and Parks Foundation. We are excited and honored to be partnering with them.

Volunteers and Staff

In 2024, our amazing volunteers accomplished an astounding amount of trail work. Through 25 events, over 230 individual volunteer efforts contributed nearly 1500 hours, which equates to nearly \$50,000 in donated labor. Alaska Trail Stewards volunteers built and maintained over 25,000 feet of trail – all by hand!

We are prepping for a great 2025. Alaska Trails staff have been meeting with land managers to plan projects both for our paid trail crews and our volunteer events. Our staff has been writing grants and scoping projects so we can hit the ground running (once the snow melts). We are excited to continue building and maintaining sustainable trails.





This work is due to your support. We are grateful to all our financial donors – especially our Pick.Click.Give donors; nearly 300 donors contributed over \$18,000. We know there are lots of great non-profits in Alaska, which is why your support means so much to us.

We are grateful for your support and look forward to making more strides for more trails in 2025 and into the future. Thanks again.

This is an opportunity to advocate for trail connections between forestry roads that will be a huge step in completing the Nepaga to Fairbanks section of the Alaska

BUY A PASS The holiday shopping season is here. You can use it to encourage people to get outside AND support some of our greatest recreational assets. Buy a pass for yourself or someone else.

 Alaska State Parks annual pass: Support state parks during a time of tight state budgets. Buy a day-use pass and your parking is paid for when you park at a state parks trailhead that requires a fee. Passes are good for the calendar year. Annual boat launch passes are also available:

know some basic information about traps and trap lines. A pamphlet and videos are available.

<u>PAMPHLET</u>: A pocket-sized pamphlet titled "Trap Safety for Pet Owners" describes the types of traps and snares that may be encountered and provides illustrated instructions on how to free pets swiftly and safely. It is produced by the Alaska Department of Fish and Game (ADF&G) and the Alaska Trappers Association (ATA). Copies are available free of charge at department offices or may be viewed on the website at: http://tinyurl.com/m6oulhk. More information, including video footage featuring trap removal instructions, is found on the department's website at www.adfg.alaska.gov (see "Sharing the Trails" under the

"Hunting > Trapping" dropdown menu).

<u>VIDEO</u>: The ATA also sells a 30-minute video, "Sharing Alaska's Trails," that includes information such as how to know if you are on a trap line, trap line safety, the physics of handling and opening traps and



snares, and tips for first-aid for pets accidentally caught in traps. The video doesn't promote trapping but deals with the practicalities of sharing the trails. A three-minute excerpt of the DVD can be found on YouTube (www.youtube.com/watch?v=Jk242jZwEAQ). To order a copy of the DVD check the ATA store (www.alaskatrappers.org). NOTE: The ATA is working on an

updated version of this video and will have it for sale on the website soon.

Most trapping seasons run from November 1 to the end of February, but the season for a few species lasts longer. Wolf traps could be active well into April.

WINTER TRAIL GROOMING PROGRAMS NEED YOUR HELP

DONATE/SERVE Winter is upon us and if there is no snow on the ground in your area, there soon will be.

Many winter trail activities require (or at least are much improved by) grooming, such as

snowmachining, skiing, mushing, and fatbiking. If you engage in an activity that is improved by grooming, please remember to support those efforts. There are several ways you can help.

If you use an area that is clearly groomed and has a grooming fund, make sure to donate. Not all trails that are groomed have a specific grooming fund, but you can also join or donate to the group that is doing the grooming. Look for signs that tell you how you can help.

You can also support the Alaska Snowtrail Grant Program, which provides funds for grooming in several areas of the state. The grooming this program provides benefits more than snowmachiners. Anyone who uses the groomed trails benefits, including fatbikers, skiers, mushers, and hikers. You can't donate to the Snowmachine Trails Program, but you can help it by making sure to register your snowmachine, which is what funds the program. You can also serve on

the SnowTRAC board, which advises the state administration on how the funds are spent. Finally, you can advocate for the program. In years past, administrations have tried to cut the program as part of budget cutting measures. However, strong advocacy has kept the program alive.

ACTION NEEDED TO HELP SLOW CLIMATE CHANGE

Climate change affects everyone, especially winter sports enthusiasts like snowmachiners, mushers, crosscountry skiers, and fatbikers.

A warming climate can mean shorter winter seasons, and more extreme events like snow droughts and rain-on-snow events. These will just get worse unless we slow climate change, which means we need to reduce our greenhouse gas emissions.

But can the actions of one or two people make a difference? They sure can. Especially if more people are doing the same. Here are two things you can do right now to help make a difference.

Fix My Funds is a group of climate and financial experts working to help you take control of your investment power and shift the economy toward a sustainable future. This group regularly has sign-on letters and petitions urging investment businesses to make more sustainable choices.

Take a personal action

Turn down the thermostat. Heck, you already know how to deal with the cold when you're outside. Do the same when you're inside! Turn down the heat in your house and put on another layer or two. Turning down the heat helps reduce the amount of fossil fuels we are using. And maybe it'll make you be able to handle those outside winter temps just a little better!



Climate change may seem like an overwhelming problem, but we humans created it one step at a time, and we can solve it that way, too. Let's do what we can to ensure that future winters still have usable snow for us and for our children, grandchildren, and beyond.

PETITION TO SUPPORT FISH CREEK TRAIL IMPROVEMENTS

SIGN PETITION The Anchorage Park Foundation had this notice in a recent email newsletter:



The Fish Creek Trail Connection provides a safe and accessible link between the Spenard, Midtown, and Turnagain neighborhoods to the Coastal Trail.

Residents have been pushing for this project since the 1997 Anchorage Areawide Trails Plan. Since then, Anchorage voters approved four municipal park bonds totaling \$500,000 in 2021, 2022, 2023, and 2024.

Now, the trail connection is in peril, and there is worry about its completion.

STEWART PUBLIC TRAIL

Friends of the Stewart Public Trail issued this letter in November alerting users of the Stewart Public Trail about a new issue with a new landowner:

Dear Friends of the Stewart Public Trail:

Subsequent to the ruling two years ago confirming the prescriptive easement, there is a new landowner on the third parcel from the trailhead. In recent weeks this landowner has posted notices

indicating no trespassing, no legal public trail easement, no legal public access, and please turn back.

The Assembly, as well as the Municipal Attorney have been notified about this, and official action may be forthcoming.

Our lawyer has advised us that the trail is public, and to use the trail as if it were public. If confronted by the landowner, he suggests we turn around and contact our Assembly members and FOST.



Please contact us if you have any questions. We will continue to update you as things progress.

The Fairbanks Borough Trails Advisory Commission had a good discussion on what's next for the panel now that the Fairbanks Comprehensive Recreational Trails Plan has passed. Below is excerpted from the Fairbanks Daily News-Miner.

The commission's tasks include inventory and review of the borough's current trails, review borough and state land disposals for potential trail needs and routing, encourage voluntary public and private subdivision efforts to incorporate new trails and review borough policy on recreational trails.

All recommendations to the borough mayor's office for review.

Short-term "low-hanging fruit" could include developing minimum trail sign standards and developing a trail education program.

Our Volunteer Trail Maintenance Team has still been hard at work on Treadwell this week, see photos. They replaced a rotting 20-foot bridge about half a mile toward EC from the Emerson trail junction with a gabion basket and culvert structure that will last a long time. The team also worked with our paid Trail Mix crew in September to build a stout log crib ramp for the new 55-foot Treadwell bridge (photo with blue tarp). We still need to fly in a few bags of gravel next spring to cap the locally mined fill to finish off the ramp, but it is rideable now.
