PUBLIC COMMENTS ON AK LONG TRAIL STUDY DUE ON APRIL 14

COMMENT The BLM has released the draft of the National Scenic Trail feasibility study for the Alaska Long Trail, open for public comment through April 14. Our key comment on the study draft is to add several routes to the “suitable” category:



- Talkeetna Backcountry route from Hatcher Pass to Talkeetna (general state land)
- Eagle River Backcountry route through alpine terrain to Eklutna and over Pioneer Peak (Chugach State Park)
- Anchorage area trails: Arctic-to-Indian Traverse, Powerline Pass, Tour of Anchorage and Moose Loop (Chugach State Park and Muni of Anchorage)

The key draft study finding is that two end-to-end routes are identified as suitable for designation:

- From Seward to Ahtna lands near Summit Lake for a length of 435.3 miles.
- From Ahtna lands near Denali Park to Fairbanks, for a length of 204.8 miles

SPRING TRAILS ARE VULNERABLE, PLEASE USE WITH CARE

TREAD LIGHTLY Alaska Trails asks that you please keep in mind how your trail activities might affect other trail users, especially in the spring.

As snow melts and the ground thaws, the trails become extremely muddy. Using muddy trails at this time can result in ruts that stay all summer when the trails dry out. Those ruts can make the trails difficult to use all summer and into the next winter. They help create erosion by keeping water on the trails.

But with a little thought, this problem can be greatly reduced.

- **Try to be patient.** Stay off the trails if you can. If you are unsure if a trail is ready to be used, check it out with the commitment to turn back if you are doing too much damage.
- **Choose low impact.** If you use the trails in several different ways, choose the method of travel that will cause the least amount of damage if you do run into some muddy sections.
- **Pick your trails carefully.** Use well-drained trails with lots of southern exposure. They typically dry out the quickest. If you just have to get muddy, please limit your activities to trails that are already thrashed.



An alternative to using trails in the spring is to get out on foot or by bike and go explore quiet subdivision roads new to you. You get to be outside, be active, and probably find out new things about your community.

TRANSPORTATION BILL CAUSES CONTROVERSY BETWEEN GROUPS

A bill in the U.S. Senate regarding funding for the Recreational Trails Program (RTP), the largest funder of trails in Alaska, has been stirring controversy.

The League of American Bicyclists recently had a call to action asking people to oppose the bill.



The League claims that the bill would pull money from the Transportation Alternatives Program (TAP), which funds bike lanes and sidewalks. The group says it supports the RTP but that funding for it should not draw away from the TAP. You can read about the group's position here: <https://tinyurl.com/y5777umt>

However, American Trails believes opposition to the bill is caused by misperceptions. The group argues that while RTP funding will flow through TAP, as "has always been the case," it

also states that the funding will pass through TAP "without affecting other Federal highway programs." You can read the group's position here: <https://tinyurl.com/3y9hwaey>

Kevin Dekkinga, director of membership and development for the League, counters that "the misperception is very much on the part of American Trails and our friends at RTC." (Rails to Trails Conservancy.) He said the League stands by its post from March 3 (link above).

Dekkinga says the League is working together with other groups to find a solution amendable to all.

"Together, we're working on a solution to move forward that doesn't come at the expense of life-saving roadway safety infrastructure and programming."

Mike Passo, executive director of American Trails, agrees and says the group is working with "bill sponsors to clarify language and intent that TA (Transportation Alternatives) would not diminish in funding if RTP is increased."

But he also warns that the writing of the bill is "not always in our control."

"We can't have a fractured coalition going into this coming fight to preserve our collective funding. It is not going to be easy."

Despite the challenges, Passo is optimistic.

"I absolutely see a path forward where we can all come to agreement on this," Passo said.



TRAPPING GROUP HAS NEW VIDEO ON DOGS AND TRAPS

The Alaska Trappers Association has a new "Sharing Alaska's Trails" video out on YouTube. The video is for non-trapping dog owners and has useful information on avoiding traps and getting dogs out of traps that have been accidentally caught. The video includes:

- (a) how to recognize if you are on a trapline trail,
- (b) how to recognize the various types of traps and snares, and
- (c) how to operate the traps and snares.

Most trapping seasons are closed now, but some still could be open, and if you are a dog owner or travel on trails with someone who has dogs, this is good information to review every year. See the video here: https://www.youtube.com/watch?v=H_LcQ_Ug1lw



The ATA and Alaska Department of Fish and Game (ADF&G) have also produced a pocket-sized pamphlet titled "Trap Safety for Pet Owners," which describes the types of traps and snares that may be encountered and provides illustrated instructions on how to free pets swiftly and safely. WATCH FOR BIRD NESTS WHEN WORKING ON TRAILS

Trail work sometimes requires downing trees or clearing shrubs. When doing so make sure not to violate the Migratory Bird Treaty Act, which makes it illegal for anyone to "take" migratory birds, their eggs, feathers, or nests. "Take" includes destroying or damaging active bird nests or eggs. Different areas of the state have different sensitive periods generally occurring between April 15 and July 25. However, if you encounter an active nest at any time leave it in place and protected until young hatch and depart. "Active" is indicated by intact eggs, live chicks, or the presence of an adult on the nest.

ALASKA STATE PARKS POSITIONS CAN INCLUDE TRAIL WORK

Alaska State Parks has a variety of seasonal positions through its the Alaska Conservation Corps (ACC), which are paid jobs, and its volunteer program. Tasks will vary and may include trail work, maintenance, fee station, or office work. Most positions begin in late May or early June. Some offices will start recruitment as early as March. Outdoor Alliance is a nonprofit coalition that mobilizes outdoor enthusiasts to protect public lands and waters. This includes, but is not limited to, climate change.

The coalition is made up of several national advocacy organizations, including Winter Wildlands Alliance, the Mountaineers, the American Alpine Club, American Canoe Association, and the International Mountain Bicycling Association. The group also relies on individuals.

According to Outdoor Alliance, “Public land and conservation policy is complex, and we know how to effect meaningful change. We do the hard work, ensuring that we’re not just talking but making a measurable impact on all public lands and waters. That means building relationships with decision makers, enthusiasts, and activists to preserve trails, create new legislation, share maps, and empower others to protect the places in their backyards and beyond.”

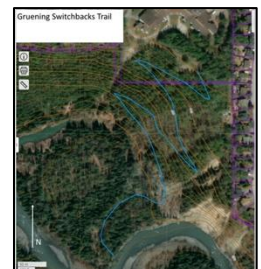

If you live in Chugiak - Eagle River, consider supporting this great project from Chugach Mountain Bike Riders to connect Gruening Middle School to the Lower Eagle River Trail. This project will construct approximately one mile of new switchbacks and connecting trail from Gruening Middle School, located on the ridge above the river, to the existing Lower Eagle River Trail at the valley bottom. Gruening Middle School borders Chugach State Park overlooking the Eagle River Valley. Currently there is no public access to this swath of public land. Access to the



park is blocked by a chain link fence due to a steep ravine leading down to the river. Design work has been completed to construct a series of switchbacks that would connect the middle school and surrounding neighborhoods to a network of trails along the river itself. This trail would be nonmotorized multiuse, as called for in the Chugach State Park Trails Plan, open to hikers, bikers, skiers, etc. It has the support of the Chugach State Park Citizen's Advisory Board, as well as Eagle River and Eagle River Valley Community Councils.

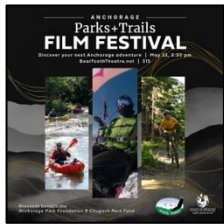

COMMENT PERIOD OPEN ON STATE FOREST MANAGEMENT PLAN

COMMENT The public has until 5 pm Friday, April 18, to comment on the draft Tanana Valley State Forest Management Plan.

The forest includes 1.8 million acres of land, including a lot of land around Fairbanks, such as in the Rosie Creek, Bonanza Creek, Standard Creek, and Cache Creek areas. The forest has many trails and forestry roads used by trail users year-round.

Trails and trail use are mentioned many times throughout the plan as a valuable asset for locals and for tourism.

An informational meeting will be held virtually from 6:30pm to 8:00 pm on Thursday April 3. A link for the virtual meeting will be posted to: <https://forestry.alaska.gov/TVSFrevision>

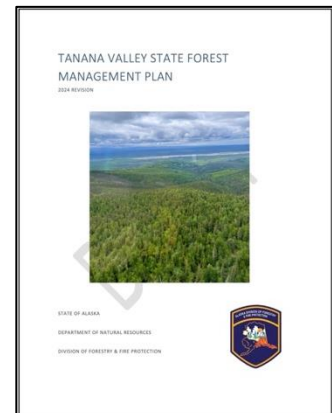
If you use trails, forestry roads, or other resources in the Tanana Valley State Forest, make sure to look through the plan and comment. If nothing else, emphasize that trails and trail use are important for local quality of life and/or tourism opportunities.

BLM GRANTS ALLOWS EXPANDED TOURS IN WHITE MOUNTAINS

BLM has issued a permit for helicopter tours and expanded snowmachine tours in the White Mountains National Recreation Area. See the following press release:

The Bureau of Land Management (BLM) Eastern Interior Field Office issued a decision approving a special recreation permit for Borealis Basecamp, LLC, to provide trail and helicopter tours in the White Mountains

National Recreation Area. The final permit addresses concerns identified by the public during scoping and includes features to reduce potential impacts to recreation, wildlife and other resources.

“Public input was valuable to understanding impacts and making a decision that provides for a wide range of user experiences in the area,” said BLM Eastern Interior Field Office Manager Tim Hammond.

Borealis Basecamp is a local resort company currently permitted to offer snowmachine and side-by-side tours in the White Mountains. The new permit authorizes continued use of the Wickersham Dome Trailhead and five miles of the Wickersham Creek Trail, where Borealis Basecamp has a warming tent. The permit has expanded to allow for one additional snowmachine tour per day from October 15 to April 10, with no more than 14 machines per trip and no more than 20 machines daily, except from March 1 to April 10, when only one trip with no more than 14 machines is authorized on weekends, holidays and during spring break.



Under this permit, Borealis Basecamp will perform regular winter trail grooming of their route to reduce trail degradation. The permit does not authorize summer side-by-side use because it was not included in the applicant's

new proposal. Fall side-by-side use from August 21 to October 14 was kept at the same use level as the existing authorization to address concerns about trail degradation.

The permit also authorizes Borealis Basecamp to provide up to three daily helicopter tours from September 16 to April 9, except for March 1 to April 9, when only one helicopter tour is authorized during the weekends, holidays, and spring break to reduce impacts during increased public recreation times. The proposed flight path and landing location were chosen to provide a scenic flight while minimizing wildlife and public disturbance.

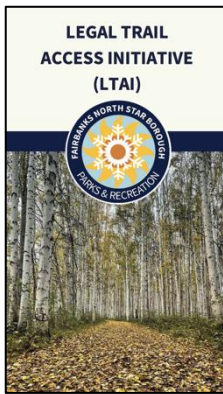

The Fairbanks North Star Borough's Parks and Recreation Department has been developing a new program, Legal Trail Access Initiative, which uses Capital Improvement Plan (CIP) funds to purchase trail easements from willing landowners to secure legal public recreational access as suggested in the Comprehensive Recreational Trails Plan. The primary goal is to reduce liability for landowners and instances of trespassing while also making it possible for the Borough to build and maintain trails which could not have funds invested in them previously due to their lack of a public easement. The Borough is currently in the process of testing the process with interested landowners who have a CRTP trail crossing their property which does not have a public access easement associated with it. Many trails in Goldstream and the greater Fairbanks area lead to private homes. Please respect signs that indicate you are on private property and turn around unless they say you can proceed. If you doubt the veracity of the signs (people rarely put up private property signs to try to keep people off public property but it occasionally happens), then do your research first and first try to work with the authorities.



Post from the Goldstream page:

Goldstream trail system users, if you come up a trail that says private trail at the start and then has two more private property signs up the trail, please do not ignore the signs. We put in a private trail this winter so we could access the lower Goldstream trails. It leads right to the back of my house and is clearly marked well before you get anywhere near my house. There is even a sign at the beginning of the trail where it ties into the trail system that it's a private trail with no outlet or turnaround.

We have had two unwelcome visitors since putting in this trail. It is extremely frustrating to have people blatantly disregard posted signs. PLEASE RESPECT PRIVATE PROPERTY. End of rant, I hope everyone is enjoying the winter trails while they last!
